

Comparison of Danial's Statements
With the Physical Evidence

Danial's Statements to the Police During his Interrogation	Physical Evidence Found at the Crime Scene or During the Autopsy
Danial said he did not ejaculate	Semen was found on vaginal swabs from Ms. Bosko's body and on the blanket found near her body
Danial said that he did not use any weapons	Ms. Bosko was stabbed with a knife
Danial said that he did not choke Ms. Bosko	Ms. Bosko was strangled
Danial said that he did not touch the blanket	Semen stains on the blanket matched the semen found on the vaginal swabs from Ms. Bosko's body
Danial said he hit Ms. Bosko a couple of times, maybe in the head, and said that he hit her three times on the side of her head with his fist	Ms. Bosko had no bruises on her face or head
Danial said the underwear he was wearing during his interrogation was the underwear he wore before and after raping Ms. Bosko	Ms. Bosko's DNA was not found on Danial's underwear, but a mixture of her DNA and Ballard's was found on the blanket near her body
Danial said he went to Ms. Bosko's apartment in his bare feet	Bare footprints from Ms. Bosko and her husband, but not from Danial, were found on the floor of the bedroom
Danial said he tossed Ms. Bosko to the floor and said Ms. Bosko was resisting while he pushed her to the back bedroom and during the rape	Ms. Bosko had no bruises or other injuries from being tossed on the floor and had no defensive or scrimmage wounds or bruises anywhere on her body
Danial said Ms. Bosko was not wearing any panties	Ms. Bosko's panties were found turned inside out on the bedroom floor near her body
Danial said he hit Ms. Bosko once on the head with a hard, flat soled shoe	Ms. Bosko had no bruises or injuries to the side of her head
Danial said he tossed the shoe away after hitting Ms. Bosko in the head	The police found no shoe near Ms. Bosko's body in the bedroom and did not seize any shoes from the apartment
Danial said he did not stab Ms. Bosko	Ms. Bosko had three penetrating stab wounds to her chest and multiple hesitation stab wounds that did not penetrate deeply into her chest
Danial said he did not see any blood when he left Ms. Bosko	Ms. Bosko was stabbed, her shirt was blood-stained, blood pooled on the floor beneath and next to her body, and blood covered her face
Danial said he pushed Ms. Bosko from the living room to the bedroom	None of the papers hanging from a shelf and protruding into the narrow hallway between the two rooms were disturbed
Danial said he used his hands to restrain Ms. Bosko's hands while raping her	Ms. Bosko had no bruises or injuries to her hands or wrists
